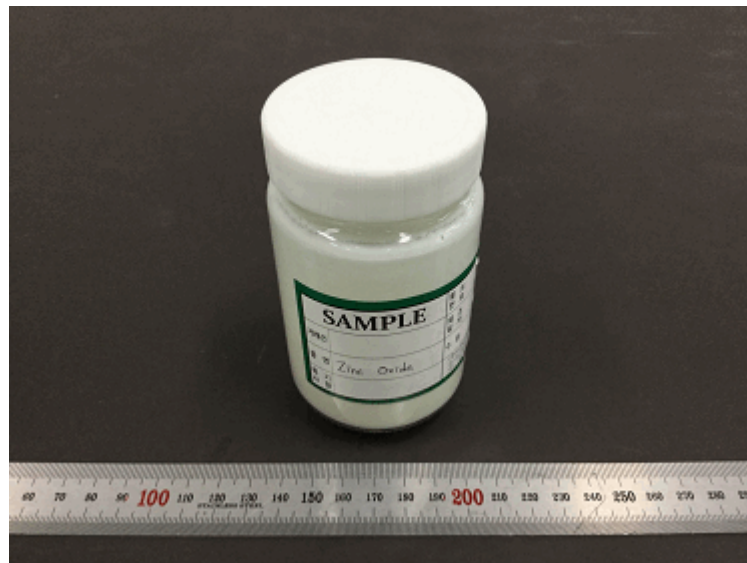

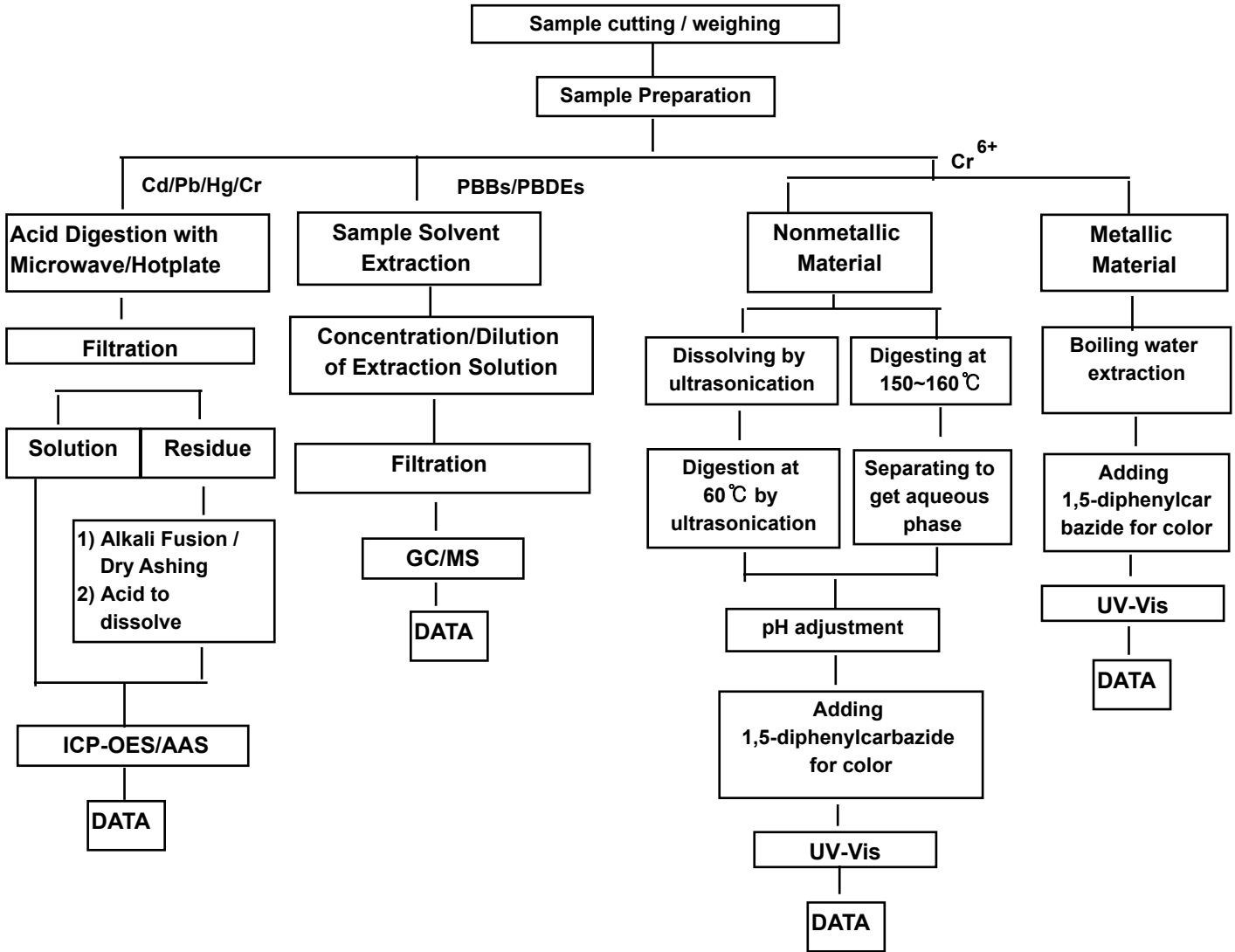
Picture of Sample as Received:

Testing Flow Chart for RoHS:Cd/Pb/Hg/Cr⁶⁺ /PBBs&PBDEs Testing



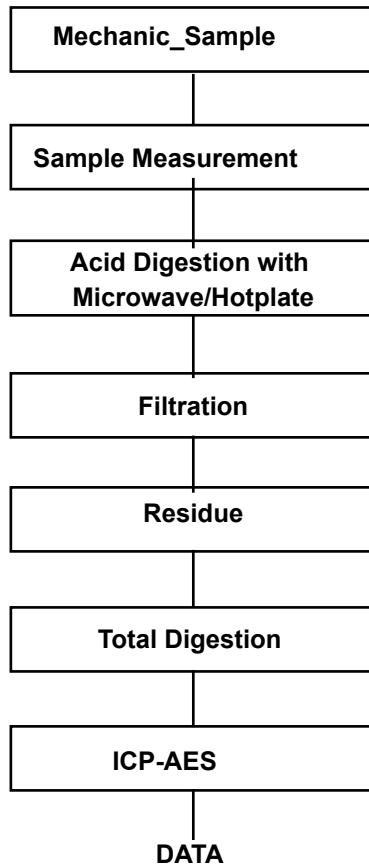

Flow Chart for Inorganic Elements Testing

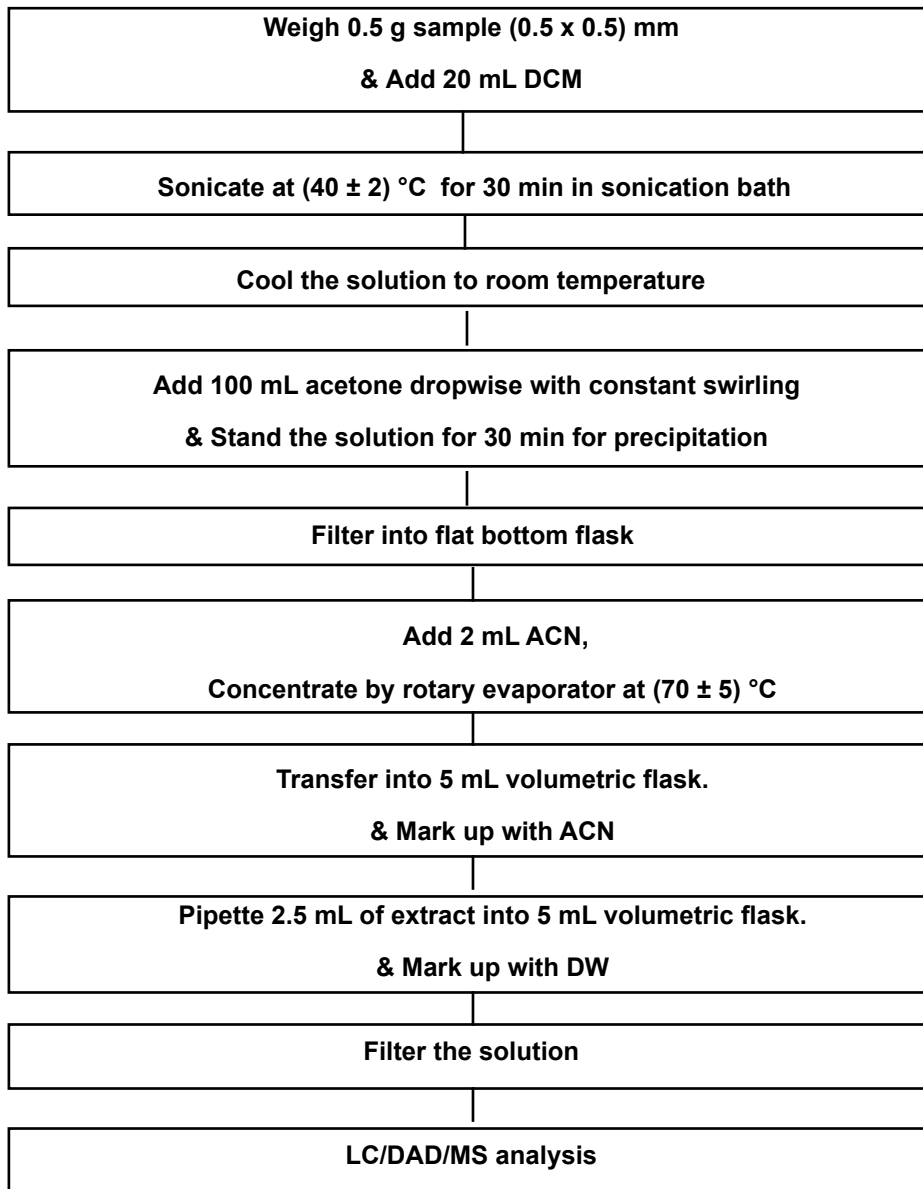
